Dear sir,

The submissions of the undersigned are as under:

1. That it is observed that the governments of center and of states are run by the alliance of political parties In spite of being run by political parties. This trend must be welcomed looking the spirit of democracy and Federal structure of constitution of India.
2. That the assessment of transparency in working of above said alliances and the assessment of democratic process of electing the main executive of alliances are not possible due to the absence of any written constitution. As per the spirit of constitution of India, the Election Commission of India ensures democracy only in the political parties when they go to this office for registration therewith. The commission doesn't have any provision to ensure the democracy within the alliances of political parties. Consequently the political alliances formed on oral basis have derailed constitutional machinery in India and hence, technically the rule of alliances of political parties is undemocratic and unconstitutional.
3. That due to the reasons mentioned above the political party of undersigned has concluded that for restoring the constitution and democracy in India, the alliances of political parties must be formed only on the basis of written constitution. The government of Union of India and of states must be run by the alliances of political parties formed on the basis of written constitution.
4. That the political party of undersigned has read it out the written constitution of alliances of political parties namely Global Alliance for Participation and Peace, GAPP. The party of undersigned has observed that the corporate houses of all countries of the world have formed Global Union for their personal financial benefits. Consequently, the economic boundaries of countries have been dismantled and just the political boundaries of the countries are survived. This unification of the corporate houses and the globalization of

market could become possible by the notorious and anti youth and anti farmers international treaty namely, "General Agreement on Tariffs and Trade, GATT committed in 1994. The said common market is maintained by World Trade Organization, WTO, the creation of GATT. The Man less production of goods by automatic machines has become indispensable for all production units to minimize the prices of the goods and to maximize the quality of the products. Due to this blind race, the production and prosperity have been enhanced but this prosperity is not reaching onto the households.
