The affidavit of the party of deponent submitted before the alliance of political parties namely "Global Alliance on Participation and Peace, GAPP in connection to declaration of adoption of contract and agreements to align with the common forum of political parties.

The political party of deponent declares the terms and conditions mentioned below of contract and agreement to align with other political parties on the common forum of alliance namely GAPP:

- For mutual cooperation, adjustment of seats in elections, common demonstration for common issues, common education, training and survey programs and for uniting and consolidating the political strength of the unorganized masses tortured by common problems but divided among various castes, communities, religions, languages, Political parties and para political alliances; The Alliance will cooperate with initiative to form the common forum, para-political fronts and alliances along with some para-political alliances whom objectives are partially or fully similar to the objectives of The Alliance.
- 1- The political party of deponent has read it out, understood properly the written constitution of alliance of political parties namely Global Alliance for Participation and Peace, GAPP, consequently declares to adopt the same.
- 2- Looking the contemporary trend of the rule of alliances in place of rule of political parties and looking the need of democratic structure, democratic output, transparency and accountability of ruling alliances; the political party of deponent will form common front or Confederation of political parties with the other parapolitical alliances, only if the concerned parties will be agreed with the following policies jointly:-
  - 2-1 political party of deponent will accommodate itself working looking the aspirations of the above said written constitution of the Alliance;
  - 2-2 To ensure the accountability to the electors, the instant affidavit is submitted without any undue pressure with free will of deponent to declare the formation of alliance or declare the will of inclusion into alliance.
  - 2-3 The political parties interested to align, will write the name of alliance with one's name as school, colleges write the name of university and their Board along with their name.
  - 2-4 The executive committees of the alliance will be constituted on that each and every level wherever any type of election related to legislative body will be present.

- 2-5 The main Executive Committee of the party of deponent declares that the deponent will involve the vertical units of party of deponent in elections as per the rules of constitution of alliance conducted to compose the vertical units of the alliance.
  - 2-6 The party of the deponent declares with oath that the upper most units of the alliance will be elected by the votes of lower most units of the party of deponent.
- 2-7 The party of the deponent declares that the party of deponent is well informed that the selection of the candidates for the elections of legislature will be the jurisdiction of collectively formed committee of the Alliance.
- 2-8 The party of the deponent declares that the party of deponent is well informed that the value of the vote of office bearers of the party of deponent for the elections of executive heads of vertical units of the alliance will be decided in proportion of Active Member of the party of deponent working within the jurisdiction of the said office bearer.
- 3- The party of the deponent declares that the party of deponent is well informed that the membership of the political parties aligned with the alliance will be categorized as per their dedication to the constitutional provisions of alliance. These categories will be opted by the political parties voluntarily as per their own choice. The rights and duties will be fixed as per the category of the membership of the concerned political party aligned with the alliance.
- 4- The judicial committees will be constituted as for as possible at each and every level of organization of the alliance to check the conflicts, apprehensions, objections, injustices occurring among the aligned political parties. The party of the deponent declares that the party of deponent will accept the verdicts issued by such judicial committees.
- 5- The party of the deponent declares that the party of deponent will align only with those political parties who will be agree to make the above one to 4 provisions the part of constitution of their political party.
- 6- The party of the deponent declares that the party of deponent is well informed that in spite of other objectives mentioned above, the alliance namely Global Alliance for Participation and Peace, GAPP will make its efforts to enact the treaty namely Global Agreement on Participation and Peace, GAPP to compensate the losses occurred from the treaty namely General Agreement on Tariffs and Trade, GATT.
